

Law No. 14 of 2010 Amending Certain Provisions of the Tenders and Auctions Regulatory Law Promulgated by Law No. 26 of 2005 14 / 2010

Articles (1-2)

We, Tamim Bin Hamad Al-Thani, Emir of the State of Qatar,

Having perused the Constitution;

The law regulating tenders and auctions promulgated by Law No. 26 of 2005, as amended by Law No. 22 of 2008,

Emiri Resolution No. 16 of 2009 specifying the functions of the ministries,

The proposal of the Minister of Economy and Finance,

The Draft Law presented by the Council of Ministers, and

After consulting the Shura Council,

Hereby promulgate the following Law:

Articles

Article 1

The texts of Articles 5, 15/ first paragraph, 51/ second paragraph, 61, 68 and 71/ first paragraph of the Tenders and Bids Regulatory Law, referred to above, shall be replaced with the following texts:

Article 5

Contracts for the procurement of goods, construction work or the rendering of services where the value of such procurement of goods, business contracts or services not exceeding QR 5,000,000 (five million Qatari Riyals) shall be concluded through Local Tenders. Such tenders are restricted to the participation of commercially registered suppliers and contractors and local services providers registered in the commercial register. Notwithstanding, all other provisions regulating public or general tenders shall be apply to the local tenders.

Article 15/ first paragraph

The Central Tenders Committee shall be responsible, upon request from the competent Governmental Body, and in accordance with the provisions of the present Law, for offering tenders of value exceeding QR 5,000,000 (five million Qatari Riyals).

Article 51/ second paragraph

If the value of the tender exceed fifty million Qatari Riyals (QR 50,000,000), the tender shall be approved by the Prime Minister upon a proposal from the Minister of Economy and Finance.

Article 61

If it appears to the Local Tendering Committee after opening the envelopes, that prices are over five million Qatar Riyals (QR 5,000,000), the Local Tendering Committee shall submit the tender documents in an envelope signed by the Chairperson to the Central Tenders Committee to take the proscribed legal procedure.

Article 68

Sale or lease with a value exceeding the sum of five hundred thousand Qatar Riyals (QR 500,000) shall be made by the CTC, and any sale or lease with a lesser value shall be made by the Local Tendering Committee in accordance with the provisions hereof.

Article 71/ first paragraph

The successful tenderer shall pay the value of the items in full within seven days, and to pay the rent on periodic instalments every six months in advance, starting from the date of the day next to the notification of award with a successful letter."

Article 2

All competent entities, each in their respective jurisdiction, shall implement this Law, which shall come into force from the date of its publication in the *Official Gazette*.
