

# Decree-Law No. 17 of 1994 Amending Certain Provisions of Decree-Law No. 5 of 1984 Organising Clubs 17 / 1994

Articles (1-3)

We, Khalifa Bin Hamad Al-Thani, Emir of the State of Qatar,  
Having perused the Amended Provisional Constitution, in particular Articles 23, 27 and 34 thereof;  
Decree-Law No. 5 of 1984 organising clubs, as amended by Decree-Law No. 21 of 1987;  
Decree No. 90 of 1990 establishing the General Authority for Youth and Sports, as amended by Decree No. 85 of 1991;  
Resolution of the Council of Ministers No. 2 of 1991 forming the General Authority for Youth and Sports, determining the competences thereof and regulating its work, as amended by Resolution of the Council of Ministers No. 6 of 1991;  
The proposal of the Chairperson of the General Authority for Youth and Sports; and  
The draft Decree submitted by the Council of Ministers;  
Hereby promulgate the following:

## Articles

### Article 1

The phrase "Supreme Council for Youth Care" shall be replaced with the phrase "General Authority for Youth and Sports" wherever mentioned in Decree-Law No. 5 of 1984, referred to above, or in any other legislation.

### Article 2

The texts of Articles 15, 17, 25/Item (d), 27/ Item 1 and 2 and 39/the first paragraph of Decree-Law No. 5 of 1984, referred to above, shall be replaced with the following texts:

#### **Article 15**

Subject to the provisions of Article 27/2 hereof, the Board of Directors shall consider acceptance of resignation submitted by one or more members, provided that the number of the remaining members shall not be less than five.

#### **Article 17**

The Board of Directors shall elect from among its members a vice-chairperson, a secretary, an assistant secretary and treasurer.

The Vice-Chairperson shall have all the competencies of chairperson, in his absence, and shall consider all works assigned to him by the Board of Directors or Chairperson.

#### **Article 25/d**

Election of a chairperson and members of the Board of Directors or filling of vacant positions on it.

#### **Article 27/1**

Dropping the membership of each or some of the members of the Board of Directors by the consent of two thirds of the working members and electing a new board of directors in the event of dropping the membership of each member of the Board of Directors, or members to fill the vacant positions in the event of dropping the membership of some of the members of the Board of Directors for the remaining period of tenure of the Board of Directors.

#### **Article 27/2**

Consideration of the resignation of the Chairperson of the Board of Directors and the resignations submitted by the members of the Board of Directors if the number of the remaining members is less than five following the acceptance by the Board of Directors of the resignations in accordance with Article 15 hereof.

Article 39/the first paragraph

Without prejudice to the provisions of Articles 29 and 30 hereof, the club may be dissolved optionally by a decision of the Extraordinary General Assembly based on the attendance and approval of a minimum of two thirds of the working members.

Article 3

All competent authorities, each within its own jurisdiction, shall enforce this Law which shall come into force thirty days after its publication in the *Official Gazette*.
