

Decree-Law No. 14 of 2000 Amending Certain Provisions of Law No. 2 of 1977 Establishing Qatar University 14 / 2000

Articles (1-4)

We, Jassim Bin Hamad Al-Thani, Deputy Emir of the State of Qatar,
Having perused the Amended Provisional Constitution, in particular Articles 22, 23, 27 and 34 thereof;
Law No. 2 of 1977 establishing Qatar University, and the amendments thereof;
The proposal of the Minister of Education and Higher Education; and
The draft Law submitted by the Council of Ministers;
Hereby promulgate the following:

Articles

Article 1

The texts of Articles 6 and 31 of Law No. 2 of 1977 referred to above shall be replaced with the following texts:

“Article 6

The University Senate shall be comprised of the following members:

- a. The Chancellor as chairperson.
- b. Vice-Chancellor for Academic Affairs.
- c. Vice-Chancellor for Research and Community Service.
- d. Vice-Chancellor for Administrative Affairs.
- e. Deans.
- f. Deans of Student Affairs and Graduate Studies.
- g. One of the Heads of Research Centres in the University chosen by the Chancellor.
- h. One of the faculty members chosen by the Chancellor.
- i. Four senior Qatari State employees and public figures, one of whom is a representative of the Ministry of Education and Higher Education and nominated by the Minister, the second a representative of the Planning Council and nominated by its Chairperson, and the third a representative of the Ministry of Civil Service Affairs and Housing.
- j. The abovementioned four members shall be appointed by a resolution of the Emir for a renewable period of three years.

Article 31

The categories of jobs, salaries and allowances issued by a resolution of the Emir upon the proposal of the University Senate shall be applied to the members of senior management, faculty, assistant teachers and lecturers in the University. Precedence shall be between the incumbents of different posts according to the order thereof as defined in Articles 9, 11, 12 (bis), 12 bis (B), 15, 16, 18 and 25 of this Law.”

Article 2

Article No. 12 bis (B) shall be added to Law No. 2 of 1977 referred to above, to read as follows:

“Article 12 bis (B)

1. The Graduate Studies Affairs of in the University shall have a dean appointed by a resolution of the Emir upon the proposal of the University Senate. The dean shall be a member of the Qatari faculty teaching staff and be at least an assistant professor.
2. The competencies of the dean shall be determined by a decision of the University Senate upon the proposal of the Chancellor. He shall have an assistant in the management of the department’s affairs, who shall replace the dean in his absence. The assistant shall be a member of the faculty and be appointed by a resolution of the Emir.”

Article 3

Each provision that violates the provisions of this Law shall be rescinded.

Article 4

All competent authorities, each within its own jurisdiction, shall enforce this Law which shall come into force from the date of its publication in the *Official Gazette*.
